SUBJECT: Allocations for Adult and Youth Programs for PY 2006
DATE: July 25, 2006

- 1. PURPOSE.** To provide Locals with the Workforce Investment Act (WIA) Adult and Youth allocations for PY 2006.
- 2. REFERENCES.** Reference is made to Letter Series 05-14 that transmitted to you the WIA percentage allocations for the Adult and Youth programs, and WIA Informational Memo 00-05-04 that transmitted planning estimates for Adult and Youth funding levels.
- 3. BACKGROUND.** The WIA Adult and Youth allocations are for the program period July 1, 2006, through June 30, 2007.

WIA ALLOCATIONS FOR ADULT PROGRAMS The State allocation for Adults is **\$2,232,342**. The State Set-Aside for Adults is 15%, which equals **\$334,852**. The remaining 85% equaling **\$1,897,490** is distributed to the Local Areas according to the percentage allocation formula.

WIA ALLOCATIONS FOR YOUTH PROGRAMS The State allocation for Youth is **\$2,740,091**. The State Set-Aside for Youth is 15%, which equals **\$411,014**. The remaining 85% equaling **\$2,329,077**. is distributed to the Local Areas according to the percentage allocation formula.

Allotments are once again taken from two Federal budgets. Funds for Adults programs will be split into PY06/FY07. I will provide you with those amounts via a separate WIN.
