Our partner, CCRS/United Security Solutions, will provide the security specific training through a well established 12 week curriculum. Subjects covered include baton use, handcuffing, OC/pepper spray, First Aid/CPR and AED certifications. RIC Outreach will provide career skills, computer training, and basic math and writing review coursework. The total program hours of 360 include 288 hours of coursework and 72 hours of internship. This training is a partnership between RIC Outreach Programs and CCRS/United Security Solutions.
