- 1) The employer's median annual wage paid to its full-time equivalent employees must be greater than the average annual wage paid by all employers in the state in the same two-digit SIC Code.  
or
- 2) The employer's median annual wage paid to its full-time equivalent employees is greater than or equal to 125 percent of the average annual wage paid by all employers in the state. (\$44,890 thru 6/30/05) (\$42,870 from 7/1/03 through 6/30/04 and \$44,890 from 7/1/04 through 6/30/05)  
or
- 3) *For manufacturing employers only* - the average annual wage paid to the employer's full-time equivalent employees classified as production workers (as defined by the Department of Labor and Training) is greater than the average annual wage paid to all production workers in the state in the same two-digit SIC Code.
