Weekly Update of Claims Activity

Week Ending: January 12, 2013

Unemployment Insurance

Initial Claims – 3,248 initial claims were processed during the week ending 1/12/13, a decrease of 92 from the previous week, and an increase of 204 from a year ago.

Continued Claims – 17,392 continued claims were processed during the week of 1/12/13, an increase of 1,042 from the previous week and a decrease of 462 from a year ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 29 initial claims and 520 continued claims were processed. An estimated 8 layoffs were prevented this week, as a result of Workshare.

Emergency Unemployment Compensation 08 – EUC08, which became effective July 6, 2008, provides up to 53 weeks of federally funded benefits to eligible individuals who exhausted their UI claims. This week there were 237 new EUC08 claims processed and 7,092 continued claims processed (2,623 under tier I, 2,220 under tier II, 1,026 under tier III and 1,223 under tier IV).

Exhaustions – 412 individuals exhausted their regular payments this week, an increase of 62 from a year ago. There were 145 individuals that exhausted EUC08.

Temporary Disability Insurance

Temporary Disability Insurance – 1,013 initial claims and 6,786 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$447 per week. Rhode Island is currently paying an average of 10.9 weeks per new claim.






UI Claims Comparison Year to Date
