## Monthly Update

Month Ending: March 31, 2016

## **Unemployment Insurance**

**Initial Claims** – 4,020 initial claims were processed during the month of March, a decrease of 3,266 (-44.8%) from the previous month, and a decrease of 504 (-11.1%) from a year ago. Of the 2,685 monetary determinations issued in March, 225 (8.4%) were monetarily ineligible.

Weeks Claimed – 50,812 weeks claimed were processed during the month of March, a decrease of 16,203 (-24.2%) from the previous month and a decrease of 20,009 (-28.3%) from a year ago. There were 48,793 payments made in March, which resulted in payments totaling \$16.7 million. There were 2,882 (5.9%) partial payments issued in March 2016 compared to 4,145 (6.3%) last year. The average weekly benefit payment was \$341. The number of weekly benefit payments is averaging 15.4 weeks per claim.

**Workshare** – 85 initial claims were processed for Workshare benefits this month, an increase of 31 (57.4%) from the previous month and an increase of 29 (51.8%) from March 2015. It is estimated that 22 layoffs were averted this month as a result of Rhode Island's Workshare program.

**First and Final Claims** – 2,247 first payments and 821 final payments were issued in March 2016. The current exhaustion duration ratio is 29.3 percent.

**Non-monetary Determinations** – 2,260 non-monetary determinations were issued during the month of March 2016. Of the 2,260 determinations, 1,337 (59.2%) were separation issues and 923 (40.8%) were non-separation issues. Denials were issued for 562 (42.0%) separation issues and 828 (89.7%) non-separation issues.

**Appeals** – 413 appeal decisions were processed with the Board of Review in March 2016. Of the 413 processed, 338 (81.8%) were filed by UI applicants and 75 (18.2%) were filed by employers. The Board upheld the director's decision in nearly two-thirds of the cases.
