

## Monthly Update

Month Ending: June 30, 2019

## **Unemployment Insurance**

**Initial Claims** – 5,443 initial claims were processed during the month of June, an increase of 2,387 (78.1%) from the previous month, and a decrease of 58 (-1.1%) from a year ago. Of the 2,834 monetary determinations issued in June 210 (7.4%) were monetarily ineligible.

**Weeks Claimed** – 27,587 weeks claimed were processed during the month of June, a decrease of 367 (-1.3%) from the previous month and an increase of 303 (1.1%) from a year ago. There were 25,637 payments made in June, which resulted in payments totaling \$9.2 million. There were 1,735 (6.8%) partial payments issued in June 2019 compared to 1,760 (7.1%) last year. The average weekly benefit payment was \$361. The number of weekly benefit payments is averaging 14.8 weeks per claim.

**Workshare** – 231 initial claims were processed for Workshare benefits this month, a decrease of 66 (-22.2%) from the previous month and an increase of 98 (73.7%) from June 2018. It is estimated that 49 layoffs were averted this month as a result of Rhode Island's Workshare program.

**First and Final Claims** – 1,633 first payments and 614 final payments were issued in June 2019. The current exhaustion duration ratio is 26.8 percent.

**Non-monetary Determinations** -1,400 non-monetary determinations were issued during the month of June 2019. Of the 1,400 determinations, 848 (60.6%) were separation issues and 552 (39.4%) were non-separation issues. Denials were issued for 355 (41.9%) separation issues and 486 (88.0%) non-separation issues.

**Appeals** -322 appeal decisions were processed with the Board of Review in June 2019. Of the 322 processed, 255 (79.2%) were filed by UI applicants and 67 (20.8%) were filed by employers. The Board upheld the director's decision in nearly two-thirds of the cases.
