SUBJECT: Allocations for Adult and Youth Programs for PY 2009
DATE: May 22, 2009

- 1. PURPOSE.** To provide Locals with the Workforce Investment Act (WIA) Adult and Youth allocations for PY 2009.
- 2. REFERENCES.** Reference is made to WIN 08-11, Change 1 that transmitted to you the WIA percentage allocations for the Adult and Youth programs.
- 3. BACKGROUND.** The WIA Adult allocations are for the program period July 1, 2009, through June 30, 2010, and the WIA Youth allocations are for the program period April 1, 2009 through June 30, 2010.

WIA ALLOCATIONS FOR ADULT PROGRAMS The State allocation for Adults is **\$3,666,405**. The State Set-Aside for Adults is 15%, which equals **\$549,961**. The remaining 85% equaling **\$3,116,444** is distributed to the Local Areas according to the percentage allocation formula.

WIA ALLOCATIONS FOR YOUTH PROGRAMS The State allocation for Youth is **\$4,364,513**. The State Set-Aside for Youth is 15%, which equals **\$654,677**. The remaining 85% equaling **\$3,709,836** is distributed to the Local Areas according to the percentage allocation formula.

Allotments are once again taken from two Federal budgets. Funds for Adults programs will be split into PY09/FY10. I will provide you with those amounts via a separate WIN.
